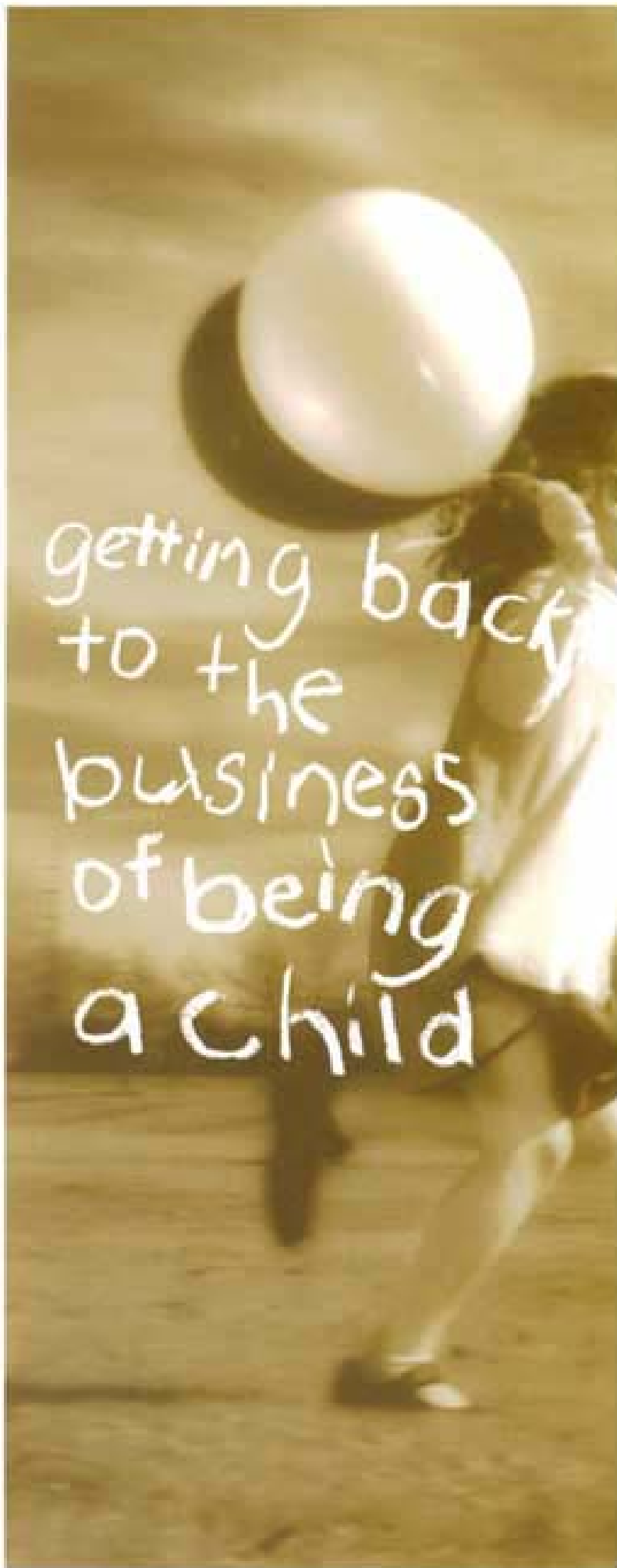

Child Protect helps over 500 abuse victims annually in Montgomery, Autauga, Elmore and Chilton Counties.

Our team includes Prosecutors, DHR, Law Enforcement and Forensic Interviewers who are trained in eliciting the specifics of abuse information from children in a non-threatening way, which also helps start the healing process. These recorded forensic interviews are admissible as evidence in court, eliminating multiple interviews and the fear and stress of courtroom testimony that can add to the trauma of child abuse.

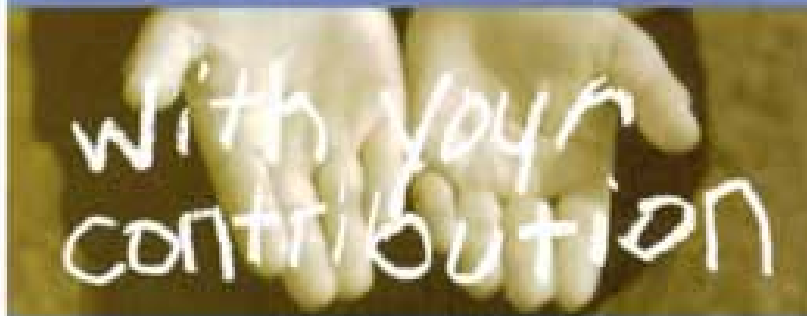

WE PROVIDE A SAFE AND SECURE ENVIRONMENT FOR CHILDREN OF ABUSE WHILE PROVIDING THE PERSONNEL AND SERVICES FOR INVESTIGATION, ASSESSMENT AND MANAGEMENT OF CASES OF ABUSE.

Child Protect is the only organization, public or private, that provides investigative services of children suspected to be victims of child abuse. We are not a state agency. We rely on the generous support of people to help children who are victims of abuse.



\$100 will help provide a forensic interview for one sexually abused child.

\$250 will help provide court accompaniment for one abused child.

\$500 will help provide 10 hours of therapy for one abused child.

\$1000 will help provide a forensic interview, court accompaniment, family advocacy and 10 hours of therapy for one abused child.
